1. Every Assessor can give maximum 10 synonyms in their each species assessment sheet.
2. Maximum five references can use in species assessment sheet which support the justification.
3. Plan must submit within 2nd week of the previous month of assessment.
4. Assessor must submit local area distribution through Project Assistant according to the plan.
5. Grid map was developing following the slandered 2*2 sq km method.





6. All plan, requisition, assessment sheet and assessment summary sheet from all respective 7 RAG must submit to National Chief Technical Expert (NCTE) through Project Manager.
7. Lead assessor must coordinate all the procedure and assessors of their respective groups.

Mr. Ishtiaq Uddin Ahmad, Country Representative, IUCN Bangladesh concluded the meeting with thanks to all participants.










