Discussion:

The meeting of the Updating Species Red List of Bangladesh with the Lead Assessors of Red List Assessment Group was held on the 08 September, 2014 at the Conference Room of IUCN Bangladesh Country Office. The meeting was discussed various issues to finalize the Session Design and Structure of the Technical Sessions of the first Information Sharing Workshop on Red List Species Assessment, participant list of the Fourth Training Workshop (23-30 November, 2014), planning of Field Visits for data collection and listing of books, scientific journals) to be collected.

Decisions and Actions:

- 1) Lead Assessors will submit list of participants for the information sharing workshop combining Assessors and technical experts by 10 September 2014.





- 2) IUCN will send a dummy presentation to all Lead Assessors to be used for preparing presentation of the workshop.
- 3) Project will prepare a 'feedback form' specially designed to collect feedback /comments on species assessment from the participants of the workshop.
- 4) The chair of the Technical Session -1 will be Prof. Dr. Md. Abul Bashar, Chairman, Department of Zoology, University of Dhaka.
- 5) The chair of the Technical Session -2 will be conducted by Dr. Shafiqur Rahman, Chairman, Department of Zoology, University of Rajshahi.
- 6) Lead Assessors will send high resolution photos of the threatened species by 10 September 2014. Project will use those in communication materials with giving photo credit.
- 7) Lead Assessors will submit list of publications and books those frequently used by their respective groups in assessment. IUCN will preserve one copy of each references/books/publications for future use. Assessors must submit journals/publications of corresponding references those only implacable for specific Species.
- 8) Assessors must submit proof of the personal communication that used in assessment as reference.
- 9) Lead Assessors will conduct necessary field survey for data collection by 30 November, 2014 for which they will submit their field visit plan within 15 September, 2014.
- 10) Project will arrange comprehensive biodiversity survey at 'Sangu Reserve' at convenient time.
- 11) Assessors will mention national elevation in the assessment sheet. But they can also mention global elevation as additional information.
- 12) Assessor will write all kinds of Bengali name, given name, common name as 'Local Name'.
- 13) For the time being, Assessor will write 'Nocturnal / Diurnal' to mention active period of the species.









